Report of the independent auditors to the Executive Board of INTERNATIONAL SOCIETY OF PAEDIATRIC ONCOLOGY Geneva

In accordance with the mandate entrusted to us, we have examined the accompanying financial statements (balance sheet, statement of income and expenses and notes) of INTERNATIONAL SOCIETY OF PAEDIATRIC ONCOLOGY (SIOP) for the year ended July 31, 2023.

These financial statements are the responsibility of the SIOP Executive Board. Our responsibility is to issue a report on these financial statements based on our review.

We conducted our examination in accordance with the Swiss Auditing Standard 910 Review (limited examination). This standard requires that we plan and perform a limited examination to obtain moderate assurance that the financial statements are free of material misstatements. A limited examination consists primarily of inquiries of company personnel and analytical procedures applied to the financial data of the annual accounts and thus provide less assurance than an audit. We conducted a limited examination and not an audit and, accordingly, we do not express an audit opinion.

Based on our limited examination, nothing has come to our attention that causes us to believe that the financial statements, showing net assets of EUR 1'952'737, do not comply with Swiss law and the association's statutes.

<u>1- GENERAL</u>

International Society of Paediatric Oncology (Société Internationale d'Oncologie Pédiatrique), Geneva "SIOP", is registered in Geneva and is as a not-for-profit association.

SIOP's vision is that no child should die of cancer.

SIOP's mission it to improve the lives of children and adolescents with cancer through global collaboration, education, training, research and advocacy.

Its office is at 7, rue François-Versonnex, 1207 Geneva, Switzerland.

2 - BASIS OF PRESENTATION AND ACCOUNTING POLICIES

These financial statements have been prepared in accordance with the provisions of commercial accounting as set out in the Swiss Code of Obligations (Art. 957 to 963b CO). The most significant accounting policies are:

a) Reporting currency

These financial statements have been prepared in Euro as this is considered as the Association's functional currency. As per Art. 958d par. 3 CO, the equivalent in national currency (CHF) of the amounts expressed in Euro has to be disclosed.

b) Foreign currencies

All assets and liabilities in currencies other than Euro are translated into Euro at the year-end closing rate whereby realized exchange results are taken to the income and expenses account. All transactions in currencies other than Euro are translated into Euro at the rate of exchange prevailing at the transaction date. Resulting exchange results are taken to the income and expenses account.

c) Other assets and liabilities

All other assets and liabilities for which no valuation is mentioned on the face of the balance sheet or the notes thereto are stated at face value.

6 – INCOME ON CONGRESS

The Congress is held once every year and organised contractually by professional congress organisers. The last Congress was held in Barcelona, Spain, from September 28th to October 1st, 2022. The society is planning to host the 2023 congress in Ottawa, Canada, from October 11th to 14th.

7 – EXTRAORDINARY INCOME (ON CONGRESS)

The extraordinary income as at 31st July 2023 is represented by the dissolution of a provision, which is not required any more, as well as a minor bonus payment from the Credit Card company.

As at 31st July 2022, the income of the SIOP Congress held in 2016 in Dublin is entirely received due to the completion of the first cycle of contracted congresses with SIOP's long-term professional congress organiser (PCO) Kenes Group.
